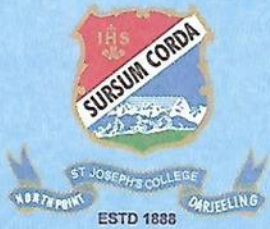
After considering various options, complying with the government circular, the **Online Classes will begin both for boarders and day-scholars from 22nd February for classes VI-VIII** for the year 2021 as uploaded in the school website. **The Online classes for classes III- V will begin on 1st March 2021. Day-scholar students of classes IX, X and XII will begin their physical classes on 23rd February.** The **online classes for the boarder students of classes IX, X and XII** will begin on the same day as well till Govt. notification to resume regular classes. **The physical classes will be held only till noon.** Class routine will be sent to all the students soon.

If a student attends physical classes it is **mandatory to submit a Consent letter** duly signed by the parents/guardian. The consent letter has been attached with this letter. I request all the day-scholar parents who wish to send their children for physical classes of IX, X and XII, to fill in the **consent form** and submit it in the school on **22nd February between 8.30 am to 2.00 pm.** The students have to be accompanied by their parent/guardian on the first day.

Textbooks for boarder students, have been dispatched from last Thursday. You will be getting them any time this week. You may call in these numbers if need be (+91 9330069183/ +91 9830069183). Those who did not wish to use the service, are requested to procure them on your own. Day-scholar students are requested to collect them from National Stores (+ 91 9932053488). **Newly admitted students** to the School, **both boarders and day-scholars**, can procure their textbooks on their own. If some boarder parents still wish the school to send them the textbooks, please send the name of the student, class, serial number and the full postal address to + 91 7407401112 at the earliest.

The present ISC 2021 students will be called to school for practical. When you are called please follow all the standard operating procedures. You will be informed about the examination dates once we receive from the Council.

Dear parents, you are requested not to send your children if they are unwell. And do not forget to inform the respective teachers immediately. The standard operating procedures will be strictly

followed by the school. The school expects students to abide by the same rules so that a safe environment is created. **Please make sure that your ward has clean uniforms and proper haircut.**

The **school canteen will not open** till further notice. The Day-Scholar students who availed the **school bus services** will be notified soon about the bus timing.

We thank you dear parents for your continuous support to NP especially during the time of COVID. Like all the other schools North Point is also on the tight ropes this year. This is where we request your generous and kind support in helping us to move forward to serve you and your ward better. Therefore the **First Installment due for boarder parents** is on **March 15, 2021 rupees 1,11,200.00** (towards boarding staff salary, tuition fees, development and maintenance and standard charge for 6 months). The second installment could be given in two parts and we will review the situation if need be.

Day-Scholar parents can follow their payments in three installments. The last date for the first installment is March 07, 2021. The fee structure will be uploaded in the School website by tomorrow. You are requested not to forget to send the receipt of your payment to the accounts office's WhatsApp number +91 9810741706. The **ONLINE FEE PAYMENT** is open now.
